This involves gathering and analysing data and other evidence to make judgments about the standards of student achievement and the effectiveness of school processes and operations. <ul style="list-style-type: none"> The Executive Team and school staff are regularly involved in self-review linked to Business Plan targets and priorities. Review and response to data occurs at the classroom, cohort and whole school level using a Disciplined Dialogue approach together with longitudinal tracking of performance data. The 2024 cycle outlines school-based assessments staff will use to collaboratively make judgements about the standards of student achievement, and the effectiveness of school processes in maximising student performance. Each cycle is mapped out against specific self-assessment tools utilised, source, responsibility, and when performance data is shared with the school staff and the school board.
